
London is known for its diversity, shopping, arts, heritage, and more - offering a great student experience.

# Postgraduate studies

*If you have recently graduated from your Bachelor's degree and are not sure of the next step, looking for a career change, or trying to get a promotion - a Master's degree sets you apart.*



## **Practical academia**

At the University of Huddersfield – London, the focus is on practical academia. You'll learn how to apply your knowledge in the real world while maintaining a research outlook.
